## Monthly report February 2021

### February NAV per share increased 0.2%

In February, the Partners Group Global Multi-Asset Fund's NAV increased 0.2% bringing the annualized inception-to-date performance to 6.6%. Below is a description of the Fund's direct add-on investment in Saur and its distribution from Biogroup-LCD.

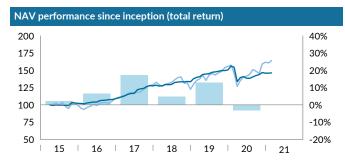
The Fund provided additional capital to Saur to fund the acquisition of Aquapor, a leading water services company focused on water supply and wastewater sanitation in Portugal. Aquapor services 26 municipalities and 1.3 million people across the country through 14 long-term concessions. The company will be an add-on to Partners Groups existing investment in Saur, a water management company in France. After the acquisition, Saur grew to become the third-largest water concessions operator in the Iberian Peninsula. Aquapor is anticipated to leverage Saur's platform capabilities to offer new technological solutions, digital services, and engineering expertise to support the Portuguese municipalities and industries in tackling water challenges.

In addition, the Fund's debt investment in Biogroup-LCD (Biogroup) was repaid following a refinancing of the capital structure. Biogroup is a group of more than 700 medical analysis laboratories based in France. The company specializes in conducting high-volume, low-complexity in-vitro diagnostic tests on body samples such as fluids, cells or tissue specimens. Established in 1998, Biogroup supports more than 75'000 patients daily with more than 2'000 routine and specialty tests performed.

The Fund offers daily liquidity at NAV which is provided subject to a maximum of 10% net redemptions per day, 25% per month and 40% per annum.

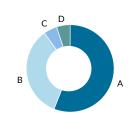
