Monthly report February 2024



February NAV per share increased by 0.7%

Global economic growth is believed to slow this year as we continue to see divergence across economies, with continued challenges observed in the manufacturing sector in comparison to services-oriented sectors. US inflation ticked up slightly again in February - the second consecutive month where it exceeded expectations. This reinforces our view that further inflation moderation will happen at a slower pace. Major central banks are therefore expected to be cautious in cutting interest rates once they pivot, which are likely to happen around mid-year.

For the month of February, Partners Group Global Multi-Asset Fund recorded an increase in performance by 0.7%, bringing the returns for the last twelve months to 5.6%. This was largely attributed to healthy distribution activity within the Portfolio's private debt and private equity investments, mainly from the Consumer Discretionary and Industrials sectors. In addition, the Portfolio recorded net positive revaluation within its private debt, private equity and listed investments in the Financials and Information Technology sectors.

On the investment front, the Fund made an additional commitment to Exus North America, a US-based provider of third-party asset management and project development services for owners of utility-scale solar, wind and battery storage projects that is transitioning into an integrated developer, owner and operator of renewable projects. The capital will be used to establish the cornerstone of Exus North America's operating and ready-to-build assets (765MW) and expand its development pipeline by 609MW to a total of approximately 1.3GW via several acquisitions.

Meanwhile, Partners Group received further proceeds from the sale of Borssele III/IV, a 731.5MW Dutch offshore windfarm. Based in the Netherlands, Borssele III/IV is a fully operational offshore windfarm comprising 77 wind turbines.


At the same time, Partners Group received proceeds from Oak Hill Capital Partners IV through the sale of Safe Fleet to trade buyer Clarience Technologies. Safe Fleet is a provider of safety and productivity solutions to fleet vehicles across North America. Oak Hill acquired a majority interest in Safe Fleet in 2018 and worked with management to build a differentiated, integrated platform of safety, productivity, and connectivity solutions for fleet vehicles via organic growth and add-on acquisitions, which expanded its product range, geographic coverage and channel access.




