September NAV per share decreased by 0.4%

In September, the NAV per share of the Partners Group Global Real Estate Fund (AUD) decreased by 0.4% for the partially hedged share class. Respectively, the NAV for the unhedged share class decreased by 0.1%.

The valuation of French Mountain Residences (Lachat) increased over the period, reflecting the positive financial performance of the premium residences. Over the last 12-month period, French Mountain Residences (Lachat)'s EBITDA exceeded budgeted expectations, driven by a substantial increase in prices. Founded in 2004, French Mountain Residences (Lachat) is located in the most prestigious ski resorts of the French Alps and comprises 35 4-star residences with a total of $\sim\!\!2'400$ apartments.

Furthermore, capital was invested in US Single Family Rental Portfolio (Kairos) to fund the purchase of a community of more than 100 homes in Pensacola, Florida to add to the portfolio. The homes were acquired from DR Horton and were close to fully leased at time of purchase. US Single Family Rental Portfolio (Kairos) is a joint venture with Kairos Living (operator) to acquire, operate and develop a portfolio of single-family rental homes across the Sunbelt region (majority in Texas, Alabama, Georgia, and Oklahoma), and provide capital for future acquisitions of such homes.

Partners Group invested capital in Seattle Office Portfolio (Evergreen) to partially repay the senior loan, which was refinanced with an American global investment company in 2021. The repayment forms part of the terms of the modification of the loan, which included the adjustment of the interest rate from floating to a fixed rate. Amid a rising interest rate environment, the loan modification would remove interest rate volatility for the duration of the loan.

The Partners Group Global Real Estate Fund (AUD) is an Australian Unit Trust with the objective of achieving long-term capital appreciation by investing in a global portfolio of real estate investments diversified by geographies, financing stages and property types. The investment strategy is led by Partners Group's relative value investment approach to optimise risk-adjusted returns by systematically overweight those segments and investment types that offer attractive value at a given point in time.

The Fund allows investors to subscribe and redeem shares on a monthly basis, thus avoiding the long lock-up periods common in most private real estate funds. The Fund may hedge certain currency exposure to reduce the risk of foreign exchange movements. The Fund is a feeder fund that invests in Partners Group Global Real Estate FCP ("Master Fund").




Portfolio composition

Investments by regional focus




