#### Unit price increased by 0.3% in February

Distribution from Safe Fleet

In February, the unit price of Partners Group Global Value Fund increased by 0.3%. The performance was driven by positive contributions from the secondary and direct lead portfolio investments, but offset by some joint investments mainly in the Healthcare and Information technology sectors. One of the positive performance contributors was Foundation Risk Partners. The US-based insurance broker was positively revalued in February 2024 on the back of continued robust financial performance. The company is enjoying a strong start to the year with double-digit organic growth in January - led by a strong performance in its Northeast region - in addition to contributions from recent acquisitions.


During the reporting month, the Fund received proceeds from the sale of its interest in Safe Fleet, a provider of safety and productivity solutions to fleet vehicles across North America, which was sold to trade buyer Clarience Technologies. Since Partners Group's co-investment in 2018, Safe Fleet has developed a differentiated, integrated platform of safety, productivity, and connectivity solutions for fleet vehicles via organic growth and add-on acquisitions, expanding its product range, geographic coverage and channel access.

Partners Group Global Value Fund is an Australian unit trust with the objective of achieving capital growth over the medium- and long-term by investing in private equity. It provides investors with a broad diversification across geographies, financing stages and investment types, while using Partners Group's relative value investment approach to systematically overweight those segments and investment types that offer attractive value at a given point in time, in order to significantly enhance risk-adjusted returns. The Fund allows investors to subscribe and redeem shares on a monthly basis, thus avoiding the long lock-up periods common in most private equity funds. The Fund may hedge certain currency exposure to reduce the risk of foreign exchange movements. The Fund is a feeder fund that invests in Partners Group Global Value SICAV ("Underlying Fund"). The Fund will invest in an AUD denominated share class of the Underlying Fund.





## Investments by regional focus




